Invitation of Public Comments



1. M/s Bharat Petroleum Corporation Limited i.e the applicant vide letter dated 23.08.2019 has submitted a proposal to this office on the above mentioned subject. The applicant is requesting relaxation from Ministry's guideline issued vide letter no. RW/NH-33023/19/99-DO.III dated 24.07.2013 as due to the "intersection with rural roads/ approach roads to private & public properties" from the proposed retail outlet is 195m as against the norm of 300m.
2. As per Ministry's vide OM No. RW/NH/33023/19/99/DO-III dated 16.03.2016, the highway administrator will make available the relaxation proposal along with Form-A in the ministry's website (morth.nic.in) for public comments for a period of 60 days.
