In continuation of this Ministry's letter of even no. dated 28/12/2018, with the approval of Competent Authority, I am directed to convey the sanction of the President to allow ROs/RPAOs to admit expenditure under LWE (Non-TSP) fund against sanctioned LWE works for the States of Andhra Pradesh, Telangana, Bihar, Madhya Pradesh, Maharashtra, Odisha, Uttar Pradesh on purely first come first served basis henceforth during 2018-19 out of the total allocation of Rs. 180 crore for the States irrespective of the States- wise allocation made; subject to the condition that office of the Principal CCA shall ensure that overall expenditure for LWE (non-TSP) does not exceed at any point of time as these would ensure that bills pertaining to well performing States are cleared without any delay and there is no gestation period involved on account of the requirement to enhance their outlay at any stage in case the states allocation is/are fully exhausted as long as the total outlay funded by LWE (Non-TSP) for States/UTs for entire country is not fully exhausted.
