- 5. In order to ensure full utilization of funds during the year, Pr. CCA is authorized to make release of fund, irrespective of the specific allocations made to States, on first come first serve basis henceforth which will be adjusted and restricted finally against the total budgetary provision i.e Rs.3000.00 crore for States.
