01.02.53 -Major Works


5. The claims would be entertained as per revised procedure vide this Ministry's letter No.RW/G-20011/2/2001-W&A dated 12.4.2001.

- (vi) No expenditure is admitted on work/portion of the work where it might have been specifically advised not to incur any expenditure pending receipt/approval of certain issues/points, etc.
