Invitation of Public Comments

SUB: Proposal for access permission and approval for New Retail Outlet abutting on NH-27 at Km 305.362 (between Km 305.345 and Km 305.380), on RHS in Block/ Survey No. 60/Paiky of Village-Samakhiali, Taluka-Bhachau, District-Kutch in the state of Gujarat.

Please refer to the Oil Company M/s. Indian Oil Corporation Limited, Rajkot's letter dated 15.10.2019 for relaxation of the subject case.

- 2. The subject proposal was submitted on Ministry's website on 07.08.2019 and it was sent by Ex. Engineer, MoRT&H, Gandhinagar vide office letter no. 737 dated 14.08.2019 to the Project Director, NHAI, PIU-Gandhidham for examination.
- 3. As per Project Director, NHAI, PIU-Gandhidham's letter no.G-8668 dt. 20.09.2019, it is noted that the case is meeting all the parameters of the guideline except for the criteria of the distance from the nearest Fuel Station is 483m against 1000m of the Ministry guidelines, so a Service Road has been proposed of 831m of length and 5.50m width. Looking to the feasibility of construction of service road at his location, it is very difficult to construct this service road of this length at there are obstructions in road side at the locations. Therefore, the Project Director, PIU-Gandhidham vide their office letter dated 20.09.2019 has considered the case of cluster of petrol pump.
- 4. Further, the Oil Company vide their letter dated 15.10.2019 has asked this office to consider the case as per relaxation in guidelines for access permission along National Highway as per MoRT&H's Circular No. RW/NH-33023/19/99-DO-III dated 16.03.2016.
- 3. In view of above, the comments of public (*if any*) on the grounds of road safety and inconvenience to road user on the abovementioned proposal, may reach to below mentioned address till <u>06.05.2020</u> beyond which no comments will be considered/entertained.
