  - Proposal for ROW Permission for laying of 66KV underground cable line Along NH-8 from Km 102+580 to Km 105+490 (Length 2+910 Kms) on Left Hand Side and Across at Km 102+580 & Km 105+490, Village-Ranoli, Taluka & District Vadodara on Ahmedabad-Vadodara Section of NH-48 in the state of Gujarat.
