INVITATION OF PUBLIC COMMENTS

Subject: NHAI, Madurai Region - Highway Administration - laying of Water supply pipeline under PIU, Tuticorin - Permission for laying Water supply pipeline by Tamilnadu Dr.J.jayalalitha Fisheries University, Tuticorin along highway from Km 5/300 to Km 6/130 Tuticorin - Tirunelveli section of NH138 (old NH7A) in the State of Tamil Nadu - **Invitation of Public Comments - Reg.**

The Proposal is regarding permission for laying of water supply pipeline from Km 5/300 to Km 6/130 on LHS on Tuticorin - Tirunelveli section of NH-138 (old NH7A) in the State of Tamil Nadu by M/s. Tamilnadu Dr.J.jayalalitha Fisheries University, Tuticorin.

2) M/s. Tamilnadu Dr.J.jayalalitha Fisheries University, Tuticorin has proposed to lay the Water supply pipeline for a length of 830 m along the edge of the ROW, which is at a distance of 44m from centerline of the project. The proposal is in conformity with Ministry's guidelines vide letter No.NHIII/P/66/76 dated 19.11.1976.

3) Further M/s. Tamilnadu Dr.J.jayalalitha Fisheries University, Tuticorin has mentioned that the Water supply pipeline along the NH by **Open Trench Method** at a depth of 1.16m.

4) Tamilnadu Dr.J.jayalalitha Fisheries University, Tuticorin has furnished an undertaking to the effect that the applicant will remove the laid Water supply pipeline in future if required by NHAI/MoRTH, Govt. of India at any time for expansion of the NH at their own cost without claiming any compensation. Further, mentioned that Tamilnadu Dr.J.jayalalitha Fisheries University, Tuticorin will also restore the surfaces to its original condition soon after removal of the Water supply pipelines.

5) As per the guidelines issued by the Ministry vide letter No.RW/NH-33044/29/2015/ S&R(R) dated 22.11.2016 the proposal submitted by the applicant will be made available for public comments and the comments is invited within 30 days from the day of uploading.
