INVITATION OF PUBLIC COMMENTS

NHAI-RO Kerala-Four Laning of Kazhakuttam to Mukkola section (Km.0+000 to Km.26+500) of NH-66 in the State of Kerala under NHDP Phase-III on EPC mode-Right of way permissions for crossing of 350mm DI pumping main at Km.15+890 to Kerala Water Authority for the works under AMRUT scheme-Reg.

The proposal is regarding permission sought by Kerala Water Authority (KWA) for crossing of 350mm DI pumping main under Atal Mission for Rejuvenation of Urban Transformation(AMRUT) scheme at Km.15+890 in the subject project stretch by HDD in the State of Kerala.

- 2. Kerala Water Authority has furnished an undertaking to shift the sewer network pipeline at their own cost at an alternate location whenever NHAI or any other road authorities make a request for shifting of the same within 30 days from the date of receipt. Further, the applicant has undertaken for payment of rent/fee as mentioned in the Ministry's Circular No. RW/NH-33044/29/2015-S&R dated 22.11.2016.
- 3. Further, Kerala Water Authority has undertaken that they will not damage any other utility during the process on laying and in case, if damaged, then to pay the losses either to NHAI or to the agency concerned. Further, KWA has also undertaken not to obstruct the drainage of the road and to ensure adequate safety measures during the execution of the work.
- 4. As per the guidelines issued by the Ministry vide letter No.RW/NH-33044/29/2015/S&R(R) dated 22.11.2016, the proposal submitted by Kerala Water Authority will be made available for 30 days seeking public Comments/objections and the comments shall be furnished within 30 days from the day of closure of public objections.
