- Proposal seeking ROW permission for laying of 450mm DIK-7 and 300mm Dia DI Pipeline along with NH-48 from Km 168+000 to Km 170+000 connecting Palej to Chavaj Water works under Narmadabara Group Water Supply Scheme in the state of Gujarat.


