### Invitation of Public Comments

**SUB:** Short Term Improvements & Routine maintenance of Surat - Vapi Section from Km. 263.000 to Km. 381.000 on NH-48 in the state of Gujarat.

- Proposal seeking ROW permission for laying of Power Cable from 220KV Atul-GIS (GETCO) S/S to 220KV Atul TSS (WR) Line 220KV 1Cx1200Sqmm (2x3) Poly Al corrugated XLPE U/G Cable line at E.P No- 195/16 (for Western Railway-Mumbai) for crossing of NH-48 at Km 344+650 (between Km 342+000 to Km 345+000) and Parallel from Km 344+650 to Km 342+200 (Total Length 2450m) on Right Hand Side, Village-Parnera, Taluka & District-Valsad in the state of Gujarat.

The Project Director, NHAI, PIU-Surat vide letter u/ref.(1) has recommended the instant proposal submitted by M/s. Gujarat Energy Transmission Company Limited-Navsari vide their office letter u/ref.(2), in compliance to PD, PIU-Surat office letter u/ref.(3), seeking ROW permission for laying of Power Cable from 220KV Atul-GIS (GETCO) S/S to 220KV Atul TSS (WR) Line 220KV 1Cx1200Sqmm (2x3) Poly Al corrugated XLPE U/G Cable line at E.P No- 195/16 (for Western Railway-Mumbai) for crossing of NH-48 at Km 344+650 (between Km 342+000 to Km 345+000) and Parallel from Km 344+650 to Km 342+200 (Total Length 2450m) on Right Hand Side, Village-Parnera, Taluka & District-Valsad in the state of Gujarat.

2. Now, as per Ministry vide OM No. RW/NH-33044/29/2015/S&R(R) dated 22.11.2016, the Highway Administration will make available the proposal seeking permission for utility laying for public comments for **30 days** on the ground of general public interest for seeking claims and objections.


