INVITATION OF PUBLIC COMMENTS

Sub:- NHAI-RO Kerala- (i) Four laning of Thalassery-Mahe bypass section of NH-17 from km.170.600 (design chainage km 170.600) to km 188.000 (design chainage km 189.200) under NHDP Phase -III on EPC mode in the State of Kerala & (ii) Six laning of Thaliparamba to Muzhapilangad section from km 137.900 to km. 170.600 of NH-17 (New NH-66) of project length 29.948 Km in the State of Kerala on Hybrid Annuity Mode under Bharatmala Pariyojana-Laying of 8 inch Steel and 90mm MDPE Gas pipeline by M/s Indian Oil Adani Gas Pvt.Ltd. from Km.161+020 to Km.188+700 in NH-17 (New NH-66)-Reg.

- The proposal is regarding permission sought by M/s IndianOil Adani Gas Private Ltd. (IOAGPL) for laying/crossing of underground Natural Gas pipeline from Km.161+020 to Km.188+700 for a length of 48.2 Km on NH-66 in the subject project stretch in the State of Kerala.
- 2. M/s IOAGPL has furnished undertaking to shift the gas pipeline at their own cost at an alternate location whenever NHAI or any other road authorities make a request for shifting of the same. Further, the applicant has undertaken to confirm with all standards as mentioned in the Ministry's Circular No. RW/NH-33044/29/2015-S&R dated 22.11.2016.
- 3. Further, M/s IOAGPL has undertaken that they will not damage any other utility during the process on laying and in case, if damaged, then to pay the losses either to NHAI or to the agency concerned. Further, M/s IOAGPL has also undertaken to manage traffic movement during the execution of the work.
- 4. As per the guidelines issued by the Ministry vide letter No.RW/NH-33044/29/2015/S&R(R) dated 22.11.2016, the proposal submitted by M/s IOAGPL will be made available for 30 days seeking public Comments/objections and the comments shall be furnished within 30 days from the day of closure of public objections.
