The Contractor should observe the condition of Ministry's letter and Technical circular No.RW/TRI/-PR/70/2018-19 dated 18/02/2019. Please note that the **Superintending Engineer, NH South Circle, Thiruvananthapuram, PWD, Govt of Kerala** reserves the right to accept or reject all or any of the BIDs without assigning any reason whatsoever.

## **Special Conditions:**

- (i) The work involves Cold milling and Hot in Plant recycling of pavement and overlay with Bituminous Concrete. Bidders having experience in similar works are expected to participate in the bidding. Bidders have to produce documentary evidence showing their experience in similar works or they should produce evidence regarding their plan to mobilize specialized agency that are having the required technical manpower and equipment for pavement milling and relaying works using Hot in plant/ Hot in place method.
- (ii) Since estimated cost of the work is more than Rs. 25 crores, use of Batch type Hot Mix Plant is mandatory for execution on BC/ DBM in the work. The bidder should own or should have assured ownership of Batch type Hot Mix Plant. Bidders have to submit documentary evidence in this regard, along with the bid.

Note:

- 1. Definite proof of owning of machineries in the form of Commercial invoice shall be treated as ownership
- 2. Placement of confirmation order for purchase of Batch type Hot Mix Plant shall also be treated as ownership. However, the tenderer shall furnish the receipt/documentary proof for payment of minimum Rs. 25.00 lakhs to the manufacturer/supplier as an assured ownership and he shall use Batch type Hot Mix Plant for the work.
