

As per the approved drawing, Concessionaire/NHAI has to complete the work of service road at Rohtak Bypass NH- 10 (New NH-9) by May 2019 as per the Clause 12.5 of the Concession Agreement. On the behalf of it, temporary access already granted dated 11.09.2018. EOT required of temporary access for one year. Relaxation is required for temporary access to complete this service road as shown in the approved drawing for more than one year, e.g., 2 years.	Due to delay in obtaining NOC from various departments although considered Deputy Magistrate-cum-Deputy Commissioner. The District Magistrate issued NOC vide letter dated 02.12.2019 even after expiry of validity of temporary access which expired on 10.03.2019. Without Deputy Commissioner NOC, Nayara Energy could not start work. Due to delay in issuing NOC by Deputy Commissioner, delay in building plan approval, security of material, labour and due to lockdown, Nayara Energy could not complete the construction of fuel station in time. EOT requires for more than one year and require relaxation. Kindly recommend EOT with relaxation.
