In inviting your kind reference to the cited letters on the subject, it is to re-submit herewith the aforesaid proposal after due reconciliation to the observations as received from E.E., P.H.Division, Berhampur for favour of kind information & necessary action.

- 1) The detail list of ROW status for laying of pipelines at three critical locations i.e. from 350/050 km to 350/075 km, 349/850 km to 349/950 km & 349/200 km to 349/500 km have been reflected in the site plan. The details of each location are mentioned below for kind perusal.
 - a) From chainage 350/050 km to 350/075 km available ROW is 23.17 mtr & pipes can be laid outside the BT Carriageway, berm & culvert for a length of 35 intrs.
 - b) From chainage 349/850 km to 349/950 km ROW is 21.95 mtr & pipes will be laid in the available space outerside of the drain wall & Airport Authority compound side.
 - c) From chainage 349/200 km to 349/500 km available mm ROW is 19.51 mtr & pipes will be laid right side edge of the BT Carriageway i.e. adjacent to existing inner wall of the road side concrete drain.
- 2) License Agreement Para No. 42 is rectified and rectified License Agreement draft is enclosed herewith.
- 3) The chainage mentioned in the forwarding letter and license deed are corrected.
