- Proposal seeking ROW permission for crossing of Water Supply Pipeline of 2742mm Dia on NH-27 at Km 583+057, Near Village-Chandisar, Taluka-Palanpur by M/s. Water Resources Investigation Division, Palanpur Division (Narmada Water Resources, Water Supply & Kalpsar Department) in the state of Gujarat.
