Executive Engineer, (O&M) Division, MSEDCL, Sangamner vide letter cited above has submitted Proposal for Laying / Crossing of Electrical Cable along / across with (Sinnar-Shirdi Section) of NH-160 for approval of the Competent Authority, Highway Administration.

- 2. From the submitted proposal, it is observed that, the Laying of 33 KV Electrical Line is proposed across Sinnar-Shirdi Section Underground cable from Km. 34.400 to Km. 36.100 (Length 1.7Km), Overhead cable from Km. 36.100 to Km. 38.500 (Length 2.5Km) on RHS along NH-160 (Total Length 4.2Km) & 01 no. of Crossing at Km. 34.400 across NH-160.
- 3. As per Para-4 of Ministry of Road Transport & Highways (MoRT&H) Circular No. RW/NH-33044/29/2015/S&R(R), Dtd. 22.11.2016, the Highway Administration shall put out in the Public Domain for 30 days for seeking claims and objections (On grounds of Public inconvenience, safety and general public interest).
