## Invitation of Public Comments

- SUB: Construction of Eight Lane Vadodara Kim Expressway from Km. 323+000 to Km. 355+000 (Sanpa to Padra of Vadodara Mumbai Expressway) in the state of Gujarat under NHDP Phase-VI on Hybrid Annuity Mode (Phase-IA-Package-II):
  - Permission seeking ROW permission for laying 4" Dia Flow Line [Padra # 102/117/118 to Padra # 125] across U/C Vadodara-Mumbai Expressway Corridor at Km 350+297, Village-Sokhadakhurd, Taluka-Padra, District-Vadodara in the state of Gujarat.
