Sub: NHAI, PIU, Coimbatore - Strengthening and Widening the existing 2 lane carriageway to 2 lane with paved shoulders from Km 0+000 to Km 85+000 of NH-544H (NH(O) Project (Thoppur -Mettur -Bhavani -Erode section) for a length of 85 Km - *Laying of Water Pipe line in NH-544H Road (Bhavani - Erode Section) Along the road from Km.78/520 to Km.78/620 (LHS & RHS), Km.78/620 to Km.79/685 (RHS) and Crossing @ Km.78/560, Km.78/800, Km.79/110, Km.79/550, Km.79/600, Km.79/935, Km.80/160, Km.80/460, Km.80/500 & Km.80/760 by Open trench & HDD method proposal submitted approval requested - reg.*

1. The proposal is regarding permission for Laying of Water Pipe line in NH-544H Road (Bhavani - Erode Section) Along the road from Km.78/520 to Km.78/620 (LHS & RHS), Km.78/620 to Km.79/685 (RHS) and Crossing @ Km.78/560, Km.78/800, Km.79/110, Km.79/550, Km.79/600, Km.79/935, Km.80/160, Km.80/460, Km.80/500 & Km.80/760 by Open trench & HDD method.
