INVITATION OF PUBLIC COMMENTS

Sub:- NHAI-RO Kerala- Six laning of Existing Kozhikode Bypass (i.e. Vengalam Jn. to Ramanattukara Jn.) from km 230.400 to km 258.800 (Design Chainage) of NH-66 in the State of Kerala under NHDP Phase-III on Hybrid Annuity Mode -Crossing of HT UG cable at Km.257+980 by Sh.Abdul Latheef V P, Kozhikode-Reg.

The proposal is regarding permission sought by Sh. Abdul Latheef V P, Kozhikode for crossing of HT UG cable at Km.257+980 in the subject project stretch in the State of Kerala.

2. Sh.Abdul Latheef V P, Kozhikode has furnished undertaking to shift the underground cable at their own cost at an alternate location whenever NHAI or any other road authorities make a request for shifting of the same. Further, the applicant has undertaken to confirm with all standards as mentioned in the Ministry's Circular No. RW/NH-33044/29/2015-S&R dated 22.11.2016.

3. Further, Sh.Abdul Latheef V P, Kozhikode has undertaken that they will not damage any other utility during the process on laying and in case, if damaged, then to pay the losses either to NHAI or to the agency concerned. Sh.Abdul Latheef V P, Kozhikode has also undertaken to manage traffic movement during the execution of the work.

As per the guidelines issued by the Ministry vide letter No.RW/NH-33044/29/2015/S&R(R) dated 22.11.2016, the proposal submitted by Sh.Abdul Latheef V P, Kozhikode will be made available for 30 days seeking public Comments/objections and the comments shall be furnished within 30 days from the day of closure of public objections.
