**Sub:** 4-laning of Madhya Pradesh/Maharashtra Border Nagpur Section of NH-7; from Km.652.000 (New Km.653.225) to Km.729.000 including construction of Kamptee - Kanhan and Nagpur Bypass and Maintenance of already 4 -laned sections from Km.14.585.000 to Km.36.600 NH-7 (Nagpur-Hyderabad Section) in the State or Maharashtra under NHDP Phase-II on DBFOT Basis- Proposal for permission for laying of 11 KV cable across the Nagpur-Jabalpur Highway on Nagpur Bypass between km 725 to km 726 under MSEDCL, Mouda Division- Approval-Reg.


