Sub: 4-laning of Madhya Pradesh/Maharashtra Border Nagpur Section of NH-7 from Km.652.000 (New Km.653.225) to Km.729.000 including construction of Kamptee - Kanhan and Nagpur Bypass and Maintenance of already 4 -laned sections from Km.14.585.000 to Km.36.600 NH-7 (Nagpur-Hyderabad Section) in the State or Maharashtra under NHDP Phase-II on DBFOT Basis- **Proposal for permission for laying of 11 KV 300 sqmm UG Cable across and along the highway on NH-44 (Nagpur-Chandrapur Highway) at 5 locations under Tender T-12 LR RDSS Butibori Division - Approval-Reg.**

It is to inform all concern that M/s MSEDCL. letter under reference (2) has submitted a proposal for the subjected work and PD, PIU-1, Nagpur has recommended the above proposal vide letter under reference (1) for approval of the Competent Authority / Highway Administrator.

2. The alignment proposed by that M/s MSEDCL for subject section of NH-44 in the State of Maharashtra is as follows:

- Laying of 11KV underground line from km 23.100 to km 24.900 & km 18.500 to km 19.900 alongwith crossings at km 29.600, km 26.800 & km 24.400.

3. As per Para-4 of Ministry's Circular No.RW/NH-33044/29/2015/S&R(R), dated 22.11.2016, the Highway Administration shall be put out in the public domain for 30 days for seeking claims and objections (on grounds of public inconvenience, safety and general public interest).

4. In view of the above, the comments / objections of affected public is hereby invited with reference to the Ministry's circular dated 28.01.2016 due to above transmission line on the subjected stretch. The objections / comments may be addressed to the below mentioned address within 30 days from issuance of public comments, beyond due date, no comments/ objections will be accepted.
