INVITATION OF PUBLIC COMMENTS

Sub:- NHAI-RO Kerala-Widening/Development of Existing NH-85 from Km 0.000 to Km 124.636 section to 2L/@L+PS section in the state of Kerala on EPC Mode under Bharatmala Pariyojana-Laying of 90mm PVC Pipeline in 110mm Steel casing pipe through HDD from Km.11+690 to Km. 11+770(LHS) and crossing at Km.11+690 of NH-85-Reg.

The proposal is regarding permission sought by M/s Hebron Aqua and Foods, Ernakulam for laying of 90mm PVC Pipeline in 110mm Steel casing pipe through HDD from Km.11+690 to Km. 11+770(LHS) and crossing at Km.11+690 of NH-85 along the subject project stretch in the State of Kerala.

2. M/s Hebron Aqua and Foods, Ernakulam has furnished undertaking to shift the pipeline at their own cost at an alternate location whenever NHAI make a request for shifting of the same. Further, the applicant has undertaken for confirming with all standards as mentioned in the Ministry's Circular No. RW/NH-33044/29/2015-S&R dated 22.11.2016.

3. Further, M/s Hebron Aqua and Foods, Ernakulam has undertaken that they will not damage any other utility during the process on laying and in case, if damaged, then to pay the losses either to NHAI or to the agency concerned. Further, M/s Hebron Aqua and Foods, Ernakulam has undertaken to bear the expenditure incurred by NHAI for repairing any damages caused to the NH by laying, maintenance or shifting of the proposed water supply line.

4. As per the guidelines issued by the Ministry vide letter No.RW/NH-33044/29/2015/S&R(R) dated 22.11.2016, the proposal submitted by M/s Hebron Aqua and Foods, Ernakulam will be made available for 30 days seeking public Comments/objections and the comments shall be furnished within 30 days from the day of closure of public objections.
