NH83) from km 123.550 to Km. 150.400 of Dindigul - Bangalore Road (Pollachi to Coimbatore Section) to four lane with paved shoulder in the State of Tamilnadu under NHDP-IV on EPC Basis - ***Request for granting permission for laying proposed 24" dia Steel Gas pipeline along with OFC duct across NH-83 from (Pollachi to Coimbatore)in Coimbatore District in the state of Tamil Nadu - Reg.***

1. The proposal is regarding permission for laying of public utility - 24" Steel Gas Pipeline along with OFC duct in the above said project chainages across RHS to LHS by HDD method at Km 0+050 in NH83 for a length of 48.53 m by M/s.Gail (India) Limited, Salem.
2. M/s.Gail (India) Limited, Salem has furnished an undertaking to accept any claims raised by the Authority, if any and the same will be paid by them and also furnished undertaking not to damage other utility, if damaged, then to pay the losses either to NHAI or to the concerned agency.
