Sub.: Maintenance Work & activities on the section from Surat to Vapi (Km 263.000 to Km 381.000) of NH-48 in the State of Gujarat (OPBMC):- **Permission for Overhead Crossing of NH-48 Km 274+800 to Km 275+000 near village Vesma Taluka & District-Navsari, for the construction of 765 KV D/C Ahmedabad-Navsari Transmission line (Part-II) associated with Transmission scheme for evacuation of 4.5 GW RE injection at Khavda PS under Phase II Part C.**
