Sub: Construction of New bridge / Structures, Repair of existing Four Lane Highways from Balasore to Kharagpur of NH-60 (Km 0.00 to Km 119.300) in the state of Orissa and West Bengal and its Operation and Maintenance under NHDP Phase- I to be executed as BOT (Toll) on DBFOT Pattern :- **Proposal for laying underground 11KV Electrical cable across the National Highways No-60 (New NH-16) at Km 54+280, Km 66+310 and Km 56+975 under Belda Division, WBSEDCL Paschim Medinipur District - Reg.**
