The Authorised Signatory, M/s Teerthanker Mahaveer Institute of Management & Technology has submitted the Proposal for laying of “Electrical Cable” underground 150MM Dia of HDPE Pipe Line from along Ch. 147+705 to Ch. 149+925 LHS side of Road is Length – 2220m on Delhi-Moradabad Road, National Highway, New NH-09 (Old NH-24) in the State of Uttar Pradesh.
