INVITATION OF PUBLIC COMMENTS

Sub:- NHAI-RO Kerala-Operation and Maintenance of Edappally-Vyttila-Aroor section of NH-66 from Km.342.000 to Km.358.750 in the state of Kerala- Accommodation of Public and Industrial Utility Service along National Highways-Laying of 100m Power cable through 110mm HDPE duct by M/s EVM Automobiles Pvt. Ltd. through HDD from Km.350+400 to Km.350+500(LHS)-Reg.

- 1. The proposal is regarding permission sought by M/s EVM Automobiles Pvt. Ltd. for laying of 100m Power cable through 110mm HDPE duct by HDD from Km.350+400 to Km.350+500(LHS) of NH-66 along the subject project stretch in the State of Kerala.
- 2. M/s EVM Automobiles Pvt. Ltd. has furnished undertaking to shift the power cable at their own cost at an alternate location whenever NHAI make a request for shifting of the same. Further, the applicant has undertaken for confirming with all standards as mentioned in the Ministry's Circular No. RW/NH-33044/29/2015-S&R dated 22.11.2016.
- 3. Further, M/s EVM Automobiles Pvt. Ltd. has undertaken that they will not damage any other utility during the process on laying and in case, if damaged, then to pay the losses either to NHAI or to the agency concerned. Further, M/s EVM Automobiles Pvt. Ltd. has undertaken to bear the expenditure incurred by NHAI for repairing any damages caused to the NH by laying, maintenance or shifting of the proposed power cable.
- 4. As per the guidelines issued by the Ministry vide letter No.RW/NH33044/29/2015/S&R(R) dated 22.11.2016, the proposal submitted by M/s EVM Automobiles Pvt. Ltd. will be made available for 30 days seeking public Comments/objections and the comments shall be furnished within 30 days from the day of closure of public objections.
