The Director /Authorised Signatory, M/s KBGB Agritech Private Limited has submitted the proposal for Provisional Permission for Laying of HT overhead Electrical Cable (Industry Utility) 11KV -3x100 Sqmm on Poles within available ROW along NH-09 from Ch. 53+272 to Ch. 54+751 (LHS) (Cable Length 1479.00 Rmt) for M/s KBGB Agritech Private Limited Bulandshahr Road District-Hapur (U.P.).
