The Executive Engineer, UP Jal Nigam (Grameen), Amroha has submitted the Proposal for permission for laying underground water supply pipe line from Km 96+300 to Km 96+660 (360m) LHS, Km 98.800 to Km 99.240 (440m) RHS & crossing by HDD method at Km 96+660 & Km 99+240 on NH-09 (Delhi-Moradabad Section) at District-Amroha in the State of Uttar Pradesh.

- As per the guidelines, issued by the Ministry vide OM No.RW/NH-33044/29/2015/ S&R(R) dated 22.11.2016, the application shall be put out in the public domain for 30 days for seeking claims and objections (on grounds of public inconvenience, safety and general public interest).
