Invitation of Public Comments


Sub: NHAI, PIU, Coimbatore - Strengthening and Widening the existing 2 lane carriageway to 2 lane with paved shoulders from Km 0+000 to Km 85+000 of NH-544H (NH(O) Project (Thoppur -Mettur -Bhavani -Erode section) for a length of 85 Km - ***Request for permission to lay underground Optical Fiber Cable (OFC) on NH 544H Thoppur Bhavani Section) Along the road from Km.23/400 to Km.31/600 (LHS) Crossing @ Km.23/400 in the state of Tamil Nadu - reg.***

1. The proposal is regarding permission for laying Optical Fibre Cable by M/s. JIO Digital Fibre Pvt. Ltd. in NH-544H Road (Thoppur-Mettur - Bhavani - Erode Road) along the road from Km 23+400 to Km 31+600 and a crossing at Km 23+400.
2. M/s. M/s. JIO Digital Fibre Pvt. Ltd, has furnished an undertaking to accept any claims raised by the Authority, if any and the same will be paid by them and also furnished undertaking not to damage other utility, if damaged, then to pay the losses either to NHAI or to the concerned agency.
