

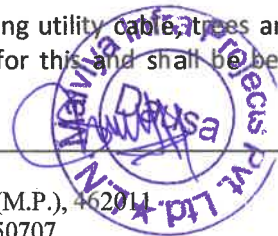

4. The applicant has submitted the undertaking of not to damage the existing utility cable, trees and Drain existing structure, in case any damage occurs then he has liable for this and shall be bear shifting and pay damages to the concerned authority.
5. The applicant has submitted the safety plan.

6. Drone video, NSV survey video and as-built drawing enclosed (as per Instruction of RO NHAI Jaipur letter no. 1057, dated 13.08.2024).

The above said proposal has been prepared in light of MORT&H guide line RW/NH-33044/29/2015/S&R(R) dated 22.11.2016 vide which applicant shall pay license fee for use of highway land.

In light of above, the permission of lying of OFC line can be given only in utility corridor of the Project Highway subject to the following conditions:

1. Before starting any work, M/s Bharti Airtel Limited should obtain necessary clearance for cut /shifting from Forest Department or other concerned department and then execute the actual work at site. .
2. The concerned department will carry out the work of shifting /relocation of above water supply pipe line whenever required in further by NHAI at their own cost as per requirement & direction of NHAI.
3. No damage to avenue plantation shall be done during laying work. In case of damages, the applicant shall restore the same at its own cost, by replacing the plants/trees of same age & height and growth.
4. Any other utility (OFC,Pipeline...etc) is already laid within the ROW. Before starting the work please concern with respective authority.
5. The applicant may strictly be advised to bring in shape the ROW after laying of OFC as it was prior to laying work.
6. In case of any damages to ongoing road work due to laying of pipeline within ROW, all costs pertaining to repair & the claims likely be raised by the independent Engineer shall be borne by the M/s Bharti Airtel Limited .
7. The applicant shall execute the work with utmost care as not to damage the existing utilities and shall be fully responsible for any damage to the existing utilities

For five years license fee is **Rs. 3,92,633/-** and Bank Guarantee amount is **Rs.3,38,300/-** for recovery of any kind of damages occurred due to improper restoration of ground filling/damages to other utilities/utility servicers & interferences, interruption, disruption or failure caused thereof to any services along the project highway ( NH-21).

In view of the above the proposal is generally satisfy ministry guideline RW/NH-33044/29/2015/S&R/(R) dated 22.11.2016, and it is recommended for grant of permission of laying OFC.

The check list and drawing have been verified and signed.
