### INVITATION OF PUBLIC COMMENTS

**Sub.:-** Construction of Six Lane access controlled highway (NH-152D) starting from Junction with Rewari-Kanina road (SH-24) near Kanina to Narnaul [ Ch. 200 + 000 to 227 + 020 ; length 27.02 km] on EPC mode under Bharatmala Pariyojana in the State of Haryana (Pkg-8) - Crossing of Electric Line of 33KV XLPE Cable 3Core X 400 Sq.mm 2nos. through HDPE Pipe 150mm Ø 2nos. connectivity with Lattice Tower at Km. 205.318 (Length 70m) in Village- Khera (Mahendragarh) and 11KV XLPE Cable (3Core X 185 Sq.mm 2nos. through HDPE Pipe 150mm Ø 2nos. connectivity with PCC H-Pole at Km. 209.278 (Length 70m) in Village- Chitlang (Mahendragarh) of Dakshin Haryana Bijli Vitran Nigam (DHBVN) (Total Length 140m) on NH-152D - reg.

By way of this public notice, it is to inform all concern that M/s DHBVN has submitted a proposal for Crossing of Electric Line of 33KV XLPE Cable 3Core X 400 Sq.mm 2nos. through HDPE Pipe 150mm Ø 2nos. connectivity with Lattice Tower at Km. 205.318 (Length 70m) in Village- Khera (Mahendragarh) and 11KV XLPE Cable (3Core X 185 Sq.mm 2nos. through HDPE Pipe 150mm Ø 2nos. connectivity with PCC H-Pole at Km. 209.278 (Length 70m) in Village- Chitlang (Mahendragarh) of Dakshin Haryana Bijli Vitran Nigam (DHBVN) (Total Length 140m) on NH-152D.

2. As per Para-4 of Ministry's circular no. RW/NH-33044/29/2015S&R(R) dated 22.11.2016 & Subsequent Amendment, Highway Administration shall put out the same in the public domain for 30 days for seeking claims objections (on grounds of public inconvenience, safety, and general public interest). The approval for publication of this notice is accorded by NHAI RO-Delhi vide letter under reference.

In view of the above, the comments/objections of affected public are hereby invited with reference to the Ministry's circular dated 22.11.2016 & Subsequent Amendment for aforesaid proposal along and across on subjected stretch. Sir,

Reference is made to note#47-55 of e-file cited under reference thereby recommending the proposal for laying of above cited subject utility through HDPE Method.

2. In this regard, it is to convey that based on the report/documents and recommendation submitted by PIU-Bhiwani office and your verification that the proposal is in conformity with the norms stipulated in the Ministry Circular dated 22.11.2016 & 17.04.2023, the Competent Authority has granted permission for above cited proposal subject to the following conditions in addition to conditions mentioned by PD/AE:

- (i) There shall be no damage to the Project Assets all along the length of the Project and within the ROW of the Project.
- (ii) The dismantled/broken section/section element of Main Carriageway, Service Road & Drain shall be restored in conformity to the existing & Project Specifications.
- (iii) The safety of workers, materials & machineries for and during execution of the said works shall be responsibility of the applicant.
- (iv) The safety of road users during execution of the said works shall be responsibility of the applicant.
- (v) The said works shall be executed with prior intimation, permission and in coordination with the Authority, Concessionaire & AE/ IE.
- (vi) Any mishap or theft due to the said work will be sole responsibility of the applicant.
- (vii) The said works shall be executed as per the norms, policies & approvals of NHAI, the Authority, the applicant shall be liable for all applicable permits & licenses for the said works.
- (viii) The NHAI and its Concessionaire shall not be liable for any mishap, consequences & responsibilities arising out of the said works at any point of time.
- (ix) The plying of traffic shall not be obstructed and prior necessary permission for any sort of traffic diversion/lane closer required for the said works shall be obtained by the applicant from the competent Authority, Concessionaire & local administration.

- (x) The applicant shall be responsible to ascertain from the respective agency regarding the location of other utilities/underground installation/facilities etc. The applicant shall be solely responsible and liable for any damage to other existing utilities and shall repair/ rectify the same at their own cost.
  - (xi) The applicant shall at no time disturb any kind of project work within NH ROW.
  - (xii) The applicant shall be liable to repair/ rectify all the assets of NH including Landscaping/ paver block/ footpath or any other project furniture at their own cost.
  - (xiii) The applicant shall submit the work programme to the concessionaire and AE/ IE before the actual execution of work.
  - (xiv) The applicant shall ensure all traffic diversions permission from the AE/ IE and the traffic police.
  - (xv) Existing drainage structure shall not be allowed to carry the lines across.
  - (xvi) The Utility services shall cross the National Highway preferably on a line normal to it or as nearly so as practicable.
3. In addition, following conditions shall be ensured by PD before issuing the permission:
- (i) The application should put out in the public domain for the 30 days for seeking claims and objections (on the grounds of public inconvenience, safety and general public interest).
  - (ii) Laying of underground utility shall be done without disturbing the traffic under the supervision of NHAI Representative.
  - (iii) Submission of performance Bank Guarantee by the applicant of requisite amount.
  - (iv) Requisite license fee/lease rental including highway crossing fee as per latest MoRT&H circular dated 17.04.2023 amended time to time.
4. Further, it shall be ensured that the cross section depth and clearances are as per the requirement of MoRT&H Guidelines.
5. The MoRT&H Guidelines shall be strictly followed and the Project Director, PIU-Bhiwani is authorized to sign the approved drawing and agreement on behalf of NHAI, after the compliance of above conditions as per MoRTH letter dated 22.11.2016 & 17.04.2023.
6. It is requested to take further necessary action accordingly.

This issues with the approval of Competent Authority i.e. RO-Delhi.
