INVITATION OF PUBLIC COMMENTS

Sub:- NHAI-RO Kerala- 4-Laning of Thrissur (Km 270.000) to Angamali (Km 316.700) and Improvement, Operation & Maintenance of Angamaly (316.700) to Edappally (Km to 342.000) on NH-47 (New NH-544) on BOT(Toll) in the State of Kerala-Laying of Water Pipeline by M/s MANSOR FOODS INDIA PVT.LTD., PALARIVATTOM from Km.334+286-Km.334+433(LHS) of NH-544-Reg.

- 1. The proposal is regarding permission sought by M/s MANSOR FOODS INDIA PVT.LTD., PALARIVATTOM for laying of Water Pipeline from Km.334+286 Km.334+433(LHS) of NH-544 in the State of Kerala.
- 2. M/s MANSOR FOODS INDIA PVT.LTD., PALARIVATTOM has furnished undertaking to shift the Pipeline at their own cost at an alternate location whenever NHAI make a request for shifting of the same. Further, the applicant has undertaken for confirming with all standards as mentioned in the Ministry's Circular.
- 3. Further, M/s MANSOR FOODS INDIA PVT.LTD., PALARIVATTOM has undertaken that they will not damage any other utility during the process on laying and in case, if damaged, then to pay the losses either to NHAI or to the agency concerned. Further, M/s MANSOR FOODS INDIA PVT.LTD., PALARIVATTOM has undertaken to bear the expenditure incurred by NHAI for repairing any damages caused to the NH by laying, maintenance or shifting of the proposed water supply line.
- 4. As per the guidelines issued by the Ministry vide letter No.RW/NH33044/29/2015/S&R(R) dated 22.11.2016, the proposal submitted by M/s MANSOR FOODS INDIA PVT.LTD., PALARIVATTOM will be made available for 30 days seeking public Comments/objections and the comments shall be furnished within 30 days from the day of closure of public objections.
