The Project Director, PIU-Bhavnagar vide u/ref. (1) has recommended the instant proposal of M/s Gujarat Water Supply & Sewerage Board, seeking <u>Permission for laying 250 mm Dia</u>. DI k7 [from Km 112.20 to Km 122.22 - Pipavav HW to Samadhiyala SHW] and 200 mm Dia.
