**Sub:** Permission to Carry out the Horizontal Direct Drilling (HDD) at NH-37 of Chainage between Km. 533+175 for laying of 11 KV underground electric cable - Reg.

The GM(P), PMU-Jorhat vide letter JRT/NHIDCL/GM/US/JH-DM/409/2024/7092 dated 12.07.2025 has submitted a proposal along with recommendation to obtain permission for crossing of 11 KV Electric Cable at Km 533+175 (Length- 60 m) on NH-715 by HDD Method. The applicant, Assam Power Distribution Company Limited (APDCL) had submitted their proposal to the PMU vide their letter dated 07.05.2025.
