Subject- Proposal for permission for laying of underground proposed 200 mm RCC drainage pipeline within NH ROW along NH 351 G from km 200/200 to km 201/800 LHS and two crossing with 150 mm Dia RCC drainage line at km 200/365 to km 201/220 at village Chotila, Talua Chotila, Dist Surendranagar in the State of Gujarat-Reg.

The Roads and Building Department, Government of Gujarat vide letter no. NHP-13-2025-401-M dated 10/06/2025 has recommended the subject cited proposal for permission for laying of underground proposed 200 mm RCC drainage pipeline within NH ROW along NH 351 G from km 200/200 to km 201/800 LHS and two crossing with 150 mm Dia RCC drainage line at km 200/365 to km 201/220 at village Chotila, Talua Chotila, Dist Surendranagar in the State of Gujarat for approval of Highway Administration cum RO, Gandhinagar.
