Sub: NHAI-PIU-NSK - Widening of existing 2 lane carriage way to 4/6 lane carriageway configuration for Dhule - Pimpalgaon (Km 265.00 to Km 380.00) section of NH-3 in the State of Maharashtra - Tapi Hydro Electric & Lift Irrigation Div. No. 2, Dhule's Proposal for Laying of 33 KV HT Underground Electric Line from Km. 270.200 to Km. 270.350 (Length 150m) along NH-3 & Crossing at Km. 270.200 (Laling village, Dhule) across NH-3.

Executive Engineer, Tapi Hydro Electric & Lift Irrigation Div. No. 2, Dhule vide letter cited above has submitted proposal for Laying/Crossing of Electrical Line along/across ROW of NH-3 (Dhule-Pimpalgaon Section) of NH-3 for approval of the Competent Authority / Highway Administration.

2. From the submitted proposal, it is observed that, the Laying of 33 KV HT Underground Electric Line from Km. 270.200 to Km. 270.350 (Length 150m) along NH-3 & Crossing at Km. 270.200 (Village Laling, Tal. & Dist. Dhule) across NH-3 within NHAI-ROW.

3. As per Para-4 of Ministry of Road Transport & Highways (MoRTH) Circular No. RW/NH-33044/29/2015/S&R(R), Dtd. 22.11.2016, the Highway Administration shall put out in the Public Domain for 30 days for seeking claims and objections (On grounds of Public inconvenience, safety and general public interest).
