The Territory Manager (Gas), Bharat Petroleum Corporation Limited, Darbhanga has submitted the aforesaid proposal for permission for laying of 10" Dia Carbon Steel underground natural gas supply pipeline along and across the roads from Sakri east (NH Km. 82.100) to Gadiari Ishani Filling station (NH Km. 124.100) under National Highway 27 - Total 42.013 Km and crossing chainages are (99+800, 102+500 & 115+300) in the state of Bihar.
