This has reference to letter mentioned above at sl. no.(i) vide which Juidco Ltd. has Sir, submitted the proposal for issuance of NOC for the subject work.

- This office vide letter dated 24.11.2023 has requested Authority's Engineer to examine the subject proposal as per MORTH Circular dated 22.11.2016 & 17.04.2023 and submit report along with recommendation for further necessary action.
- Authority's Engineer vide letter dated 04.12.2023 has examine the proposal and following observations which was communicated to Juidco Ltd. vide this office letter dated 11.12.2023.
- As, structure at Ch:34+000 & 38+760 is box type, hence it is not permissible to cross the pipe below the structure it should be crossed either start or end of reinforced wall.
- Laying of pipe along the NH-33 from chainage 38+800 to 42+000 in RHS shown in line diagram, without considering avenue plantation available between chainage (ii) 38+800 to 39+700 RHS.
- Juidco Ltd. vide letter dated 27.12.2023 has submitted parawise compliance of the observations raised by this office.
- This office vide letter dated 03.01.2024 has forwarded the above submission of Juidco Ltd. to AE- M/s Lion Engineering Consultant Pvt. Ltd. for examining the proposal as per
