**Invitation of Public Comments**

**Sub:** National Highway Crossing proposal of 400 KV D/C (Twin) Nangal Bibra- Bongaigaon Transmission line to cross over NH-17 from Assam section: Proposal of 02 (two) crossing at i) Village-Bahalpur, existing Chainage-936.422 KM (at proposed bypass) & ii) village-Jaligura, proposed chainage-27.686 KM - Reg.


The GM (P), PMU-Bongaigaon vide letter PMU-BNGN/B-G/Pkg-2/EL/23-24/4583 dated 29.02.2024 has submitted a proposal along with recommendation for according 02 crossings permission along NH-17 for 400 KV D/C (Twin) transmission line viz. AP 46/5 to AP 47/0 at chainage Km 27+686, & AP 44/0 to AP 45/0 at chainage Km 936+422. The applicant, Nangalbibra- Bongaigaon Transmission Limited had submitted their proposal to the PMU vide their letter: NBBG-SPGL-DAAS-LT-542 dated 15.02.2024. The GM(P), PMU-Bongaigaon has certified the proposals, checklist and drawings as per the extant practice.

2. The subject cited NH Section will be developed to a 4 Lane facility at Chainage KM 27+686 and the NH section is being bypassed at Chainage KM 936+422.
3. As per Ministry's circular no.RW/NH-33044/29/2015/S&R(R) dated 22.11.2016 and subsequent modification dated 15.01.2021, the Highway administrator will make available the subject proposal on the portal for 30 days seeking for public comments on ground of public interest.
4. In view of the above, the comments of the public are invited on the captioned proposal and the same should reach the below mentioned address till 30 (thirty) days from the date of public interest.
