The Executive Engineer, RDW&S Division, Davanagere vide letter cited above, has submitted the proposal for laying water pipe line of Rural Drinking Water & Sanitation Department, Davanagere Division as execute Multi village water supply Jalajeevan Scheme along & across along NH-50 (Old NH-13) from Mudlamachikere cross Km. 509.500 (Old Km. 388.500) to Kalledevarapura Km. 516.300 (395.300) on LHS (6800) One crossing at Km. 510.350 (389.350) for the total length of 6.80 Kms. for approval of the Competent Authority, Highway Administration.

2. From the submitted proposal, it is observed that, the laying of water pipeline along from Mudlamachikere cross Km. 509.500 (Old Km. 388.500) to Kalledevarapura Km. 516.300 (395.300) on LHS (6800) One crossing at Km. 510.350 (389.350) of Hospet - Chitradurga section of NH 13 (New NH-50).
