1. The subject proposal is requesting permission for Erection of 33KV Over Head Electrical Transmission in 3lay Power Cables line & 503 C/C Intervals poles along the RoW from Km.78/112 to Km.81/612 on RHS in the project stretch of Tindivanam to Krishnagiri Section of NH-77(Old NH-66) in the State of Tamil Nadu.
2. M/s. Eternal Renewables Private Limited, Coimbatore has furnished an undertaking to move the utility line for any work of improvement or repairs to the road, if NHA considers it as necessary, in future, it will be carried out as desired by the NHA at their cost within a reasonable time (not exceeding 90 days) of the intimation given. Eternal Renewables Private Limited, Coimbatore will be made available for 30 days seeking public comments / objection and shall be furnished within 30 days from the day of closure of public objections.
