Sub: Proposal for permission of laying/erection of 11KV Overhead electric line from Km. 149.050 to Km. 149.200 (RHS), Total length 150mtr. on NH-34 (Ghaziabad -Aligarh Section) in District- Aligarh in the State of Uttar Pradesh.

Sub-Divisional Officer, Electricity Distribution Division-VI, DVVNL-Aligarh submitted the proposal for laying/erection of 11 KV O/H electric line from Km. 149.050 to Km. 149+200 on NH-34 (Ghaziabad - Aligarh Section) in the State of Uttar Pradesh.

2. From the submitted proposal, it is seen that the overhead erection length is proposed for 150m. As per the guidelines, issued by the Ministry vide OM No.RW/NH-33044/29/ 2015/ S&R(R) dated 22.11.2016, the application shall be put out in the public domain for 30 days for seeking claims and objections (on grounds of public inconvenience, safety and general public interest).

3. In view of the above, comments of the public on the above application is invited to the below mentioned address, which should reach by this office within 30 days from the date of publication beyond which no comments shall be entertained.


