M/s Kerala State Electricity Board has proposed for laying 11 KV UG cable from Km. 96/900 (Lulu commercial complex at Manippuzha near Nattakam) to Km. 98/702 (110 KV substation Kodimatha) on NH-183 by HDD method. EE(NH) Kollam submitted that Kodimatha bridge (of 80m length) is having utility ducts on both sides and proposed 11 KV UG cable shall be laid through existing utility ducts.

4. M/s Kerala State Electricity Board has furnished an undertaking that, they will shift the utility at their own cost if required for expansion of reach by MORTH/NHAI/PWD or any other Highways authorities within the time frame prescribed by MORTH/NHAI/PWD.
