Invitation of Public Comments

<u>Sub</u>: Permission for crossing/laying of 11 KV XLPE cable through (160mm dia. pipe) HDD method for crossing of NH-34 at Km. 114.720 in Kanpur road, Mahoba by DVVNL, Mahoba in the State of UP.

The Executive Engineer, Dakshinanchal Vidyut Vitran Nigam Ltd (DVVNL), Mahoba has submitted the proposal through PD, PIU-Kanpur for permission for crossing/laying of 11 KV XLPE cable through (160 mm dia. pipe) HDD method for crossing of NH-34 at Km. 114.720 in Kanpur road, Mahoba by DVVNL, Mahoba in the State of UP.

2. From the submitted proposal, it is seen that the crossing length is proposed 80m (40m x 2). Left side from center line towards increasing chainage/ km direction is 20m and Right side from center line towards increasing chainage/ km direction is 20m. Diameter of the Electric line is 160mm (2 Nos.). Width of available ROW is 40m of the proposed location. Laying/crossing work will be carried out through Horizontal Directional Drilling (HDD) method only. The existing NH is 2-lane.

3. As per the guidelines, issued by the Ministry vide OM No.RW/NH-33044/29/ 2015/ S&R(R) dated 22.11.2016, the application shall be put out in the public domain for 30 days for seeking claims and objections (on grounds of public inconvenience, safety and general public interest).

4. In view of the above, comments of the public on the above application is invited to the below mentioned address, which should reach by this office within 30 days from the date of publication beyond which no comments shall be entertained.
