



Further, observations were raised by the Regional officer, MoRTH, Bengaluru vide letter cited at ref(2). The proposal was re-examined by the Assistant Executive Engineer, National Highway sub-division, Bengaluru in accordance with the norms laid down by the Ministry's circular no.RW/NH-33044/29/2015/S&R(R) dated 22nd November 2016 and NH-36094/01/2022-S&R (P&B)(E-208825) dated 24.04.2023.

It is to bring to your kind notice that this is an additional road crossing requirement by M/s Indian Oil Corporation Ltd. The Chainage differs by 5.00m apart from earlier approved proposal at Km.17.638 on NH-207.



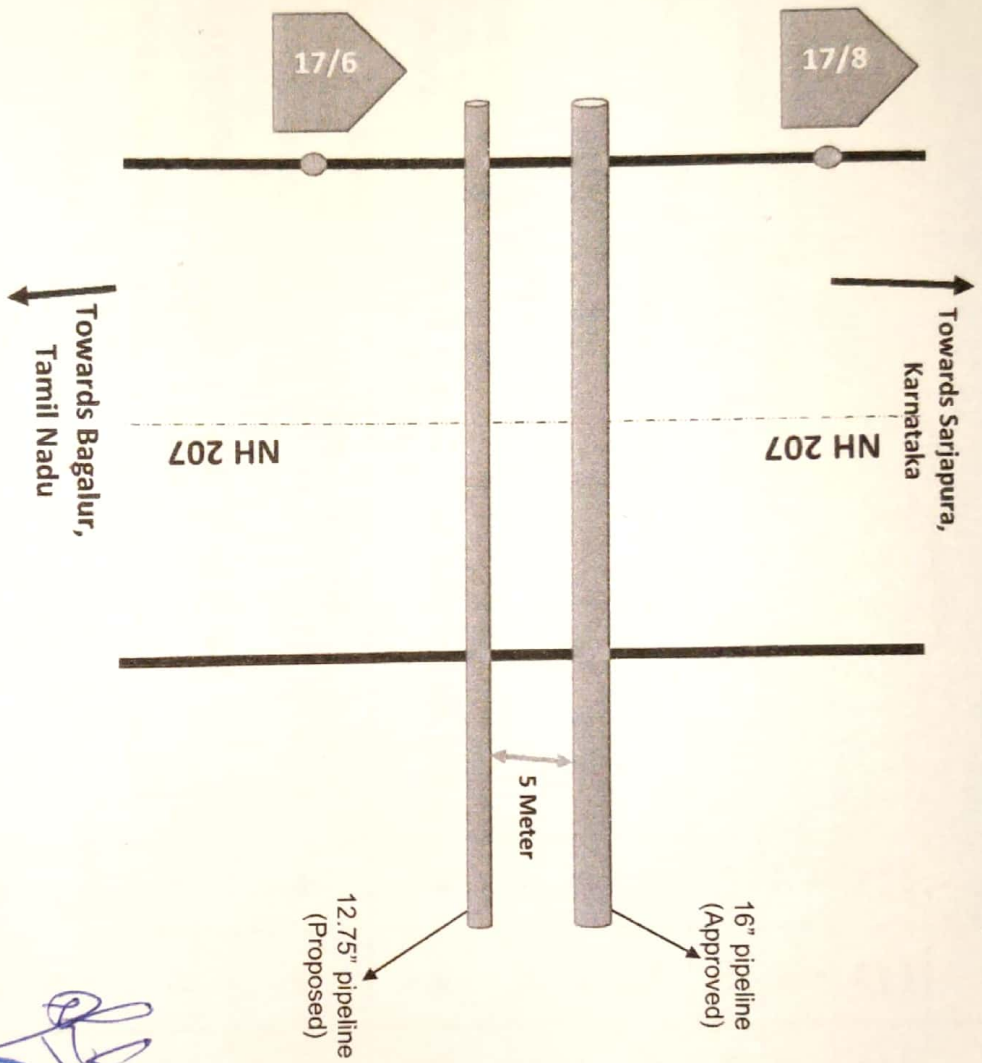
