Project Director, NHAI, PIU-Dhanbad vide letter dated 14.09.2023 has submitted the proposal of Jharkhand Urja Sancharan Nigam Limited (JUSNL) for the NH-23 (Ch. Km. 18+978) crossing between location no. 4/0 to 5/0 for Engineering, Supply of Materials/Equipment, Erection, Testing and Commissioning of LILO of one circuit of 220KV D/C, 3-phase, TTPS-Govindpur Transmission Line at GSS Jainamore (Bokaro) between NHAI Ch. Km. 18 to Ch. Km. 19 with recommendation for issuance of NOC.
