Sub: NHAI-PIU-NSK-Four laning of Sinnar to Shirdi Section of NH 160 from Design Ch:0/000 to 50/943 including Sinnar Bypass of 3.375 km in the State of Maharashtra on Hybrid Annuity Mode-Proposal from Maharashtra State Electricity Distribution Company Ltd.'s (MSEDCL) for crossing 11 KV underground Electrical Cable under RDSS Scheme at Km. 3.600, Km. 15.000, Km. 20.400 & Km. 30.400 across NH-160.
