It is to inform all concern that Rural Water Supply Dept. Zilla Parishad, Jalgaon vide letter under reference (2) has submitted a proposal for the subjected work and PD, PIU Dhule has recommended the above proposal vide letter under reference (1) for approval of the Competent Authority / Highway Administrator i.e. Regional Office, Nagpur.

2. The alignment proposed by Minor Irrigation Dept. Dhule is across subject work as follows:

- Laying of water pipeline from km 377.350 to 376.800 & km 382.360 to km 385.960 and crossing at km 377.350.

3. As per Para-4 of Ministry's Circular No.RW/NH-33044/29/2015/S&R(R), dated 22.11.2016, the Highway Administration shall be put out in the public domain for 30 days for seeking claims and objections (on grounds of public inconvenience, safety and general public interest).
