It is to inform all concern that M/s Maharashtra State Electricity Distribution Company Ltd. letter under reference (2) has submitted a proposal for the subjected work and PD, NHAI, PIU, Aurangabad has recommended the above proposal vide letter under reference (1) for approval of the Competent Authority / Highway Administrator.

2. The alignment proposed by that M/s Maharashtra State Electricity Distribution Company Ltd. is along Yedshi - Aurangabad Section of NH-52 (old NH-211) in the State of Maharashtra is as follows:

- Laying of 33 KV Cable km from Ch. 312.620 to km Ch. 317.520 on NH-52 at edge of ROW.
